1. Rig up. Pull rods & pump. Install BOP. Pull tubing.
2. Perforate 5 1/2" OD Csg w/1-JSPF @ 5718', 5731', 5738', 5752', 5763', 5798', 5794', 5808', 5820', 5830', 5873', 5885', 5897', & 5905'.
3. Set RBP @ 5950' & packer @ 5650'.
4. Acidize 5 1/2" Csg perforations 5718'-5905' w/2000 gal 15% NE Acid.
5. Frac w/25,000 gal. Viscous gelled water in 5 equal stages using 1 to 3 lbs 20/40 sand/gal. & 3 ball sealers after each stage.
6. Run production equipment, test and place on production as Blinebry-Drinkard Downhole Commingle.
