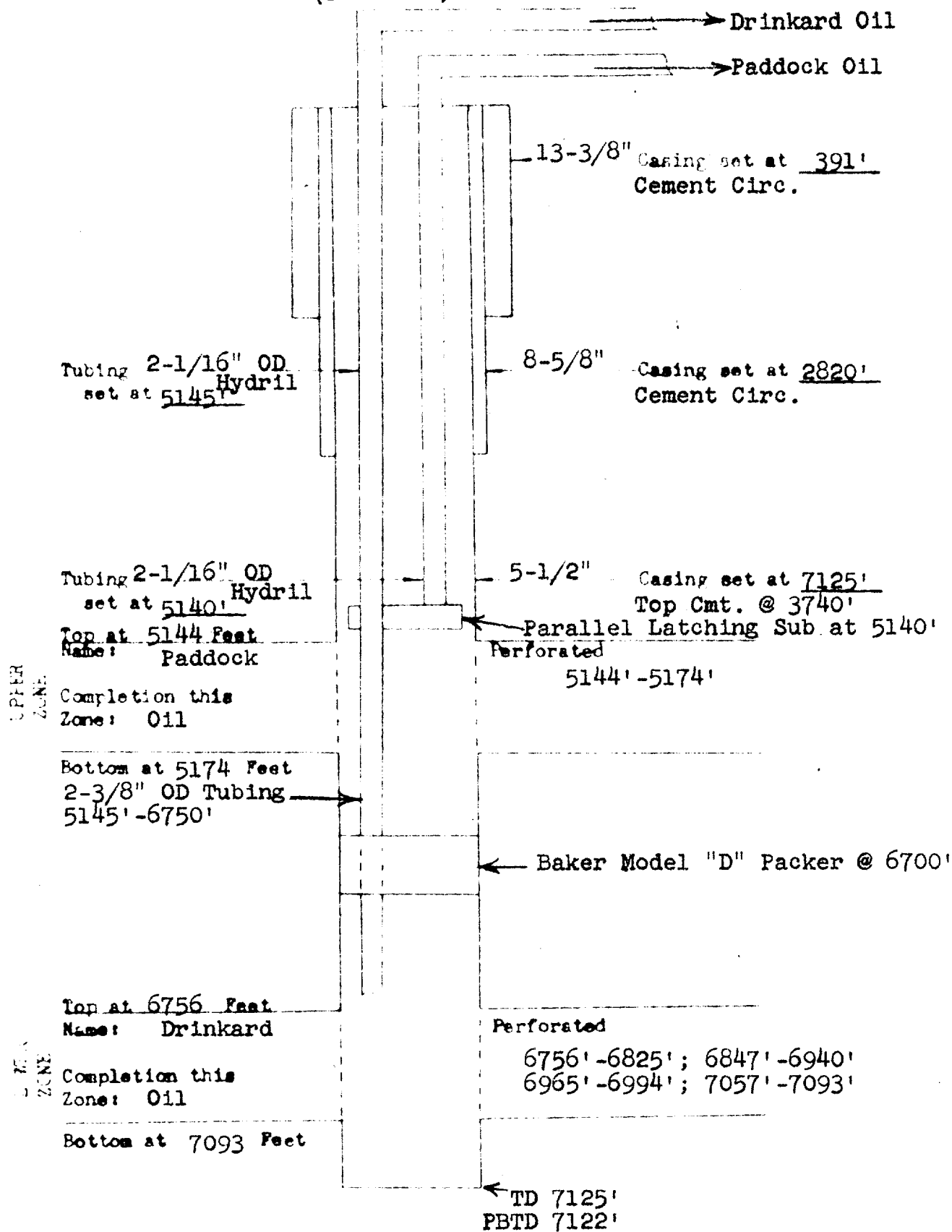

(PROPOSED)

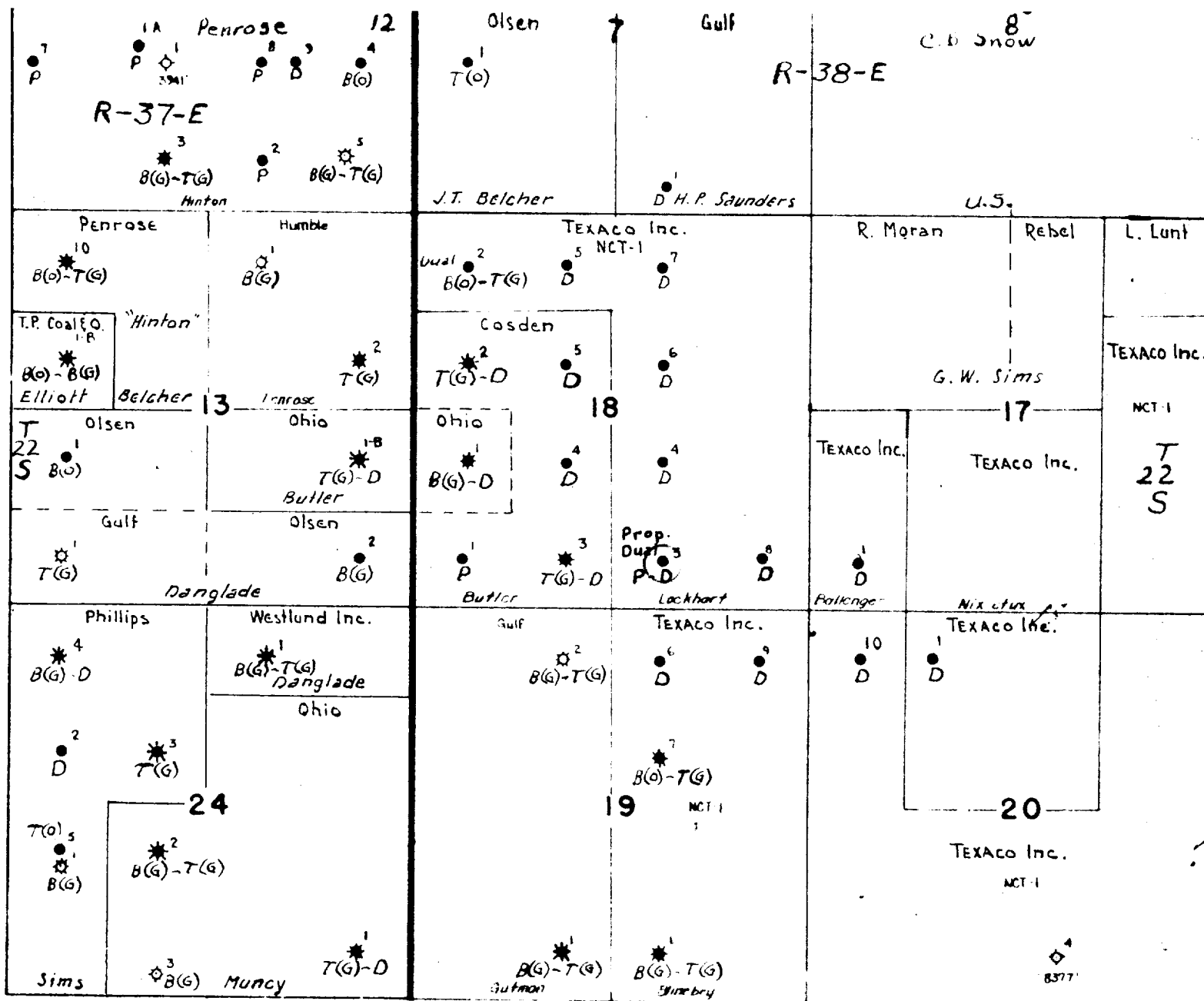
