To increase production we propose to do the following work.

1. Acidize open hole Section from 6840' to 7110' with 1000 gallons non-emulsion acid.
2. Follow with fracture treatment down the casing consisting of 20,000 gallons gelled acid and kerosene carrying one pound of said per gallon employing temporary plugging material. Flush with 225 barrels of lease crude. Shut well in.
3. Clean out to total depth if necessary.
4. Swab, Test, and return well to production.
