DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 176 Jts and cut jt (6738.50') 7" OD 23# Gr N-80 and J-55 SS casing. Set and cemented at 6749' with 331 sacks 8% Gel, 144 sacks 4% Gel and 150 sacks Neat on bottom. Plug at 6685'. Maximum pressure 1200#. Job complete by Howco 98PM 10-12-54.

After waiting over 30 hours, tested 7" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 6685' to 6749' and tested cement below casing shoe with 800# for 30 minutes. No drop in pressure.
