Tested 9 5/8" OD Casing for 30 minutes with 1000 PSI from 5:00 to 5:30 a.m. August 6, 1961. Tested O.K. Drilled cement plug and re-tested for 30 minutes with 1000 PSI from 7:30 to 8:00 a.m. August 6, 1961. Tested O.K. Job complete 8:00 a.m. August 6, 1961.
