On June 25, 1945 the 7" OD Casing was cemented in line at 6,910' by the Halliburton bulk process with 575 sacks 2 1/2" aquagel cement and 125 sacks neat cement; plug pumped to 6,875'. Job started at 6:00 p.m. June 24th and completed at 8:30 a.m. June 25th.

7" OD Casing as follows:

44 jts. 2 3/8" S. Rnd. Thd. Range 2 National N-30 S. S. Casing on bottom 1,412'
174 jts. 2 3/8" S. Rnd. Thd. Range 2 National J-55 S. S. Casing 5,492'.
(Total tallies 6,904' - Casing 8'.)
