After acidizing on 7-19-45, with 2000 gallons from 6950 to 7368', well swabbed 180 barrels oil in 18 hours. After second stage on 7-21-45, with 10,000 gallons from 6881 to 7368', well swabbed 114 barrels oil in 14 hours.
