The hole was washed down and the casing tested with 1200# pressure applied for 15 minutes. The plug was drilled and the hole tested with 1200" pressure applied for 15 minutes. Both tests were OK, and after approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to complete well.

Temperature survey shows top of cement behind 7" casing at 2910' from the surface.
