Set at 6785'. Cemented with 575 sacks 2½ and 125 sacks Neat Atlas bulk cement. Job started 3:30 AM and completed 3:15 PM August 9, 1947.

Propose to drill plug and test shut-off at 3:15 PM August 11, 1947.
