Drilled 11" hole to depth of 2820'. Ran and cemented 8 5/8" casing to depth of 2819. Cemented top by temperature survey at 134' from surface. After waiting on cement 30 hours pressured up on casing to 1200 psi and pressure held for 1/2 hour. Shut off satisfactory.

Used 610 sacks of Diamix, 305 sacks of regular wf 98 sacks of Bentonite, 200 sacks of regular neat.
