a Non-Standard 120-acre Gas Proration Unit, Blinebry
Gas Pool, Lea County, New Mexico

Gentlemen:

In compliance with Rule 30, Order No. R-1670, which prohibits the simultaneous dedication of acreage to an oil and to a gas well, Gulf Oil Corporation respectfully requests administrative approval of a non-standard 120-acre Blinebry Gas Proration Unit covering the S/2 NE/4 and NE/4 SE/4 of Section 31-22S-38E, Lea County, New Mexico. This non-standard unit will be attributed to our Scarborough Estate Well No. 3.

In support of this application, the following facts are submitted:

1. Gulf's Scarborough Estate Well No. 3, located 660 feet from the east line and 1980 feet from the south line of Section 31 is completed in the Blinebry Gas Pool and by Order No. R-1230 in Case No. 1485 dated August 6, 1958, the Commission approved a non-standard 160-acre Gas Proration Unit covering the NE/4 NE/4, S/2 NE/4 and NE/4 SE/4 of this Section 31.
2. Gulf's Scarborough Estate Well No. 1, located 660 feet from the north and east lines of this Section 31, has been dually completed in the Blinebry and Drinkard Oil Pools.
3. The proposed non-standard gas proration unit consists of contiguous quarter-quarter sections but does not lie wholly within a single governmental quarter section.
4. The entire non-standard gas proration unit is reasonably presumed to be gas productive in the Blinebry Gas Pool.
5. The length or width does not exceed 2,640 feet.
6. All operators in the quarter sections in which the proposed non-standard unit is located and within 1500 feet of the unit well, have been furnished a copy of this application.
