Well drilled to a TD of 5803; On 2-25-61 4-1/2" OD 9.5# casing was run and set at 5803' with 350 sx. Incon 8% gel and 350 sx. Pozmix. Top cement 1920' after WOC 24 hours tested casing with 1500 psig with no loss in pressure. Set cast iron bridge plug at 5220' and capped with 1 sx. cement. Perforated 5155-5180 with 2 JSPP. Spotted 500 gal. 15% over perforations and then acidized with 500 gal. Released rig. Well to be evaluated after rig move.


