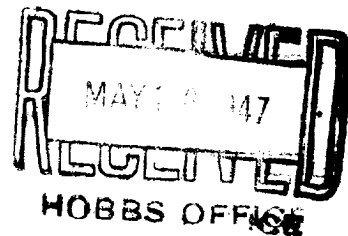

## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On May 9th at 12:00 p.m., 24 hrs. had elapsed since setting 313' of 13-3/8" OD 36# Casing in subject well to be used for surface string. Casing was cemented with 300 sacks cement. At this time casing shut-off was tested as follows: A pressure of 750# was built up and held for 30 minutes. Test was o.k. Cement plug was drilled and a pressure of 750# again built up and held 30 minutes. This test was also o.k., and drilling operations resumed.
