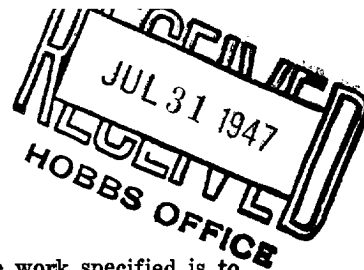

FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

At 1:30 A.M., on July 27th, 1947, 24 hours will have elapsed since running 13 3/8" O.D. new 36# Armo casing and setting at 291 feet, cementing with 310 sacks cement, to be used as surface string. At the time mentioned, casing shut-off will be tested as follows:

A pressure of 750# will be built up and held for 30 minutes, and if test is OK, cement plug will be drilled and a pressure of 750# again built up and held for 30 minutes. If this test, too, is OK, drilling operations will be resumed.
