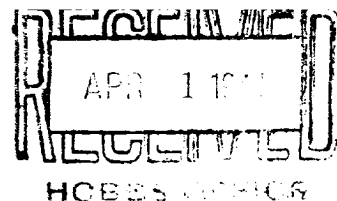

MISCELLANEOUS REPORTS ON WELLS

Following is a report on the work done and the results obtained under the heading noted above at the Cities Service Oil Company Brunson "B" Well No. 2 in the Center NE SW of Sec. 3, T. 22S, R. 37E, N. M. P. M., Drinkard Field, Lea County.

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to total depth of 2805'. Ran 2676.56' of 8 5/8" casing, cemented with 1000 sacks, set at 2687.56'. After letting cement set for 52 hours, drilled plug and tested casing by applying 1000# pressure with all valves closed. Let stand for 1 hour during which time pressure did not drop.
