AFFIDAVIT

Before me, the undersigned authority, on this day personally appeared M. S. Schiller, Vice-president of Aurora Gasoline Company, a corporation, who being by me first duly sworn, on his oath deposes and says:

That on the 20th day of June, 1951, the Aurora Gasoline Company acquired Oil and Gas Lease covering a part of the NE/4 of Section 34-T22S-R37E, Lea County, New Mexico, which lease covers the lands more fully described as follows:

SE/4 of NW/4 of NE/4 and SW/4 of NE/4 of NE/4 and NE/4 of SW/4 of NE/4 and NW/4 of SE/4 of NE/4, all in Section, Township and Range hereinabove set forth.

That, under the terms of the Assignment by which the said Aurora Gasoline Company acquired said Oil and Gas Lease it was obligated upon the completion of the well drilled thereon to elect to retain ownership of said lease or should they determine that they did not desire to further operate or produce the well drilled on the lease acquired that the interest obtained by them from C. E. Willingham and Viola L. Willingham would be reassigned.

The rights of Aurora Gasoline Company under assignment from C. E. Willingham and Viola L. Willingham were not exercised and the ownership of said oil and gas lease was reassigned to the said C. E. Willingham and Viola L. Willingham, by assignment dated the 17th day of October, 1951.
