## DETAILS OF WORK

It is our intention to drill a well at the above location to an approximate depth of 5,350' to attempt a completion in the Upper Bell Canyon horizon. All casing points will be cemented in accordance with approved methods of the U.S.G.S. and any special requirements will be complied with.

It is planned to use the following casing pattern: 11" hole, 7 5/8" casing to be set at 375' and cemented w/200 sacks cement. Cement is to circulate. 6 3/4" hole, 4 1/2" casing to be set at 5,350' and cemented w/250 sacks cement. Cement is to return to 4,800'. Permission is requested to perform the above work and to produce this well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

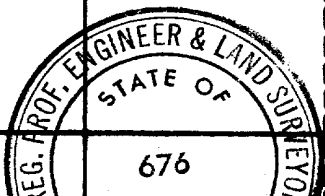

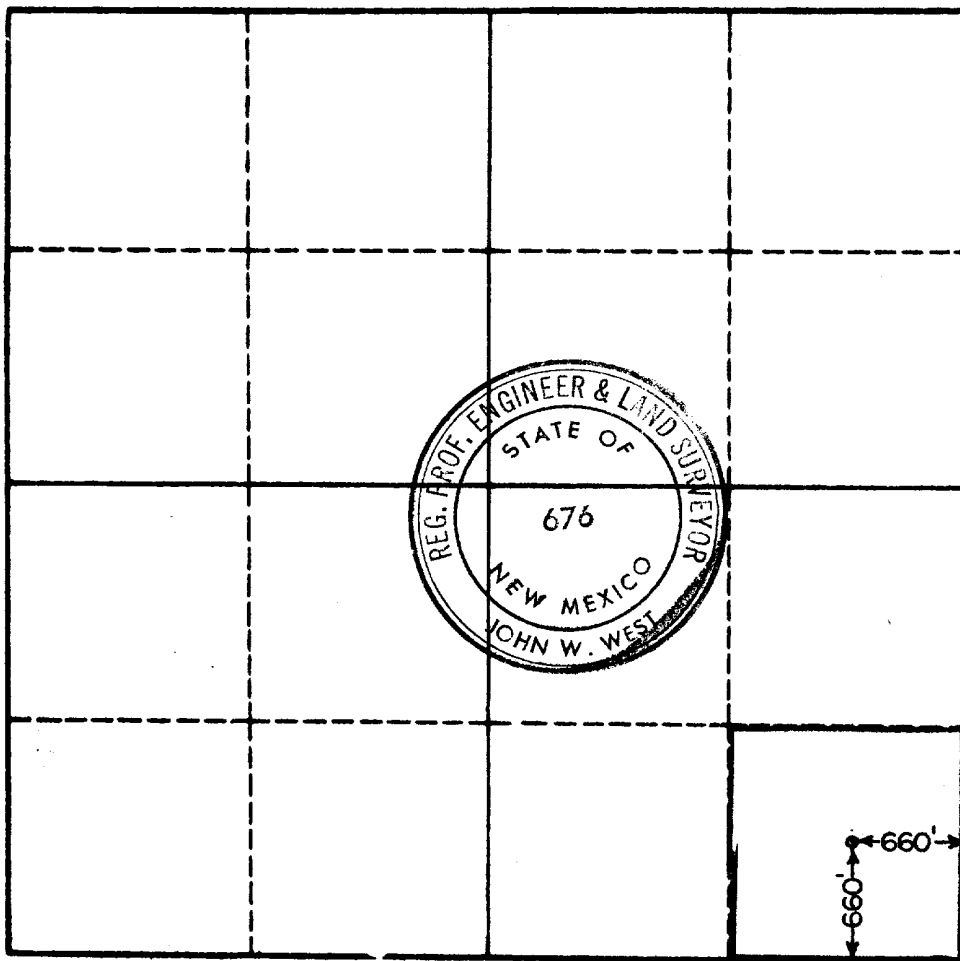
