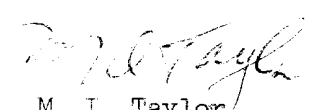
Gentlemen:

Gulf Oil Corporation herewith submits application for approval of a dual completion for the Scarborough Estate Well No. 7, located 1650 feet from the south line and 1650 feet from the west line of Section 31, Township 22 South, Range 38 East, Lea County, New Mexico. It is proposed to complete this well in the Blinebry Oil and an undesignated Ellenburger Oil Pools and to produce each zone through parallel strings of 2-3/8 inch tubing installed in 7 inch casing.

Attached is completed form Application for Multiple Completion, lease plat, and diagrammatic sketch of the proposed dual completion. It is requested that this matter be set for Examiner Hearing at an early date.

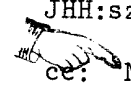

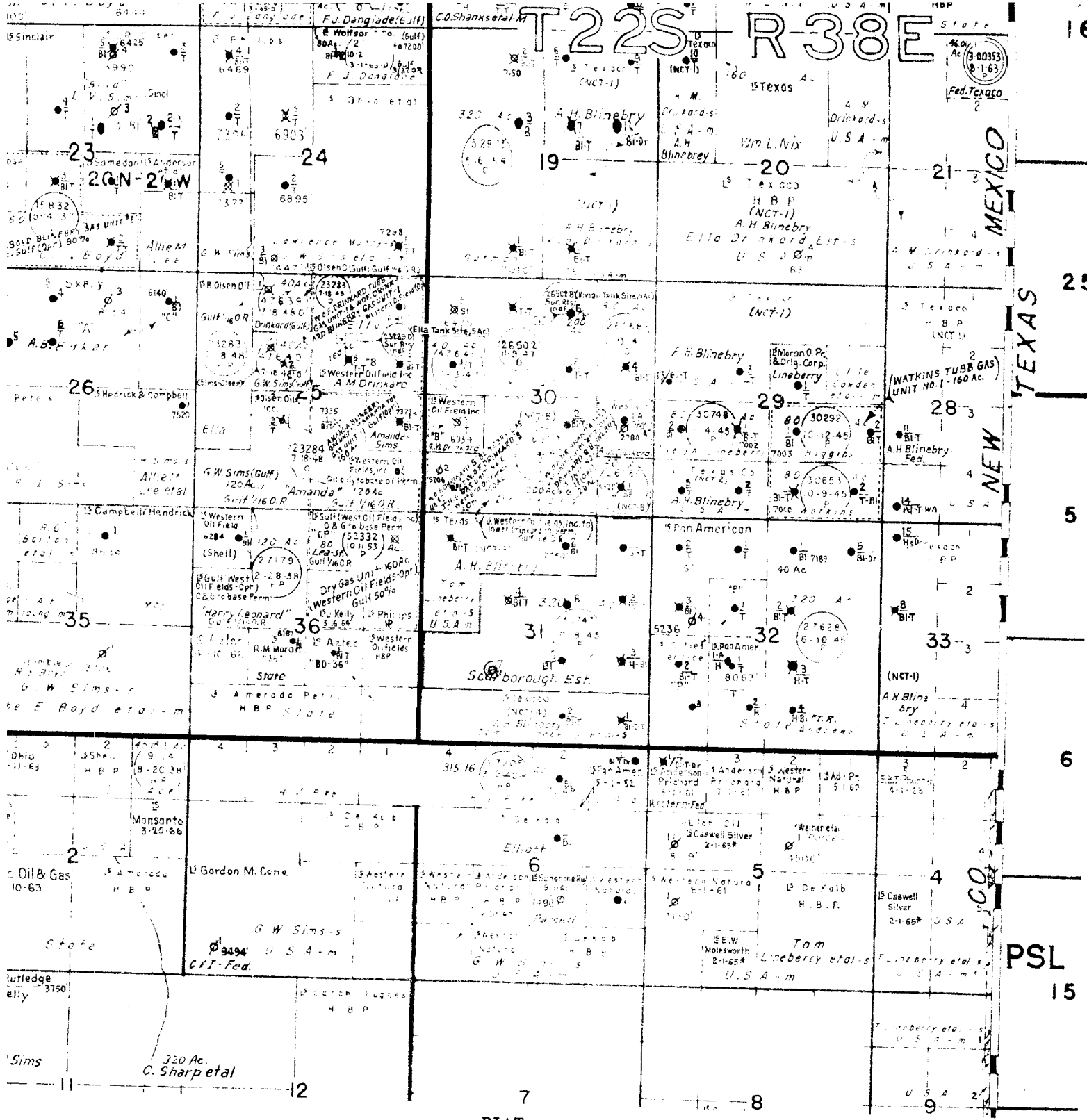

If, after said twenty-day period, no protest nor request for hearing is received by the Santa Fe office, the application will then be processed. If the proposed multiple completion will result in an unorthodox well location and/or a non-standard perforation unit in either or both of the producing zones, then separate application for approval of the same should be filed simultaneously with this application.
