1. Killed Blinbry zone, pulled rods, pump and seating nipple in Drinkard zone.
2. Ran 1-5/8" drill pipe in Blinbry zone, pumped 100 barrels fresh water down casing, unable to get circulation, drilled dry 4'.
3. Spotted 2 - 5 barrel formaseal blocks, pulled 1-5/8" drill pipe.
4. Ran 1-5/8" drill pipe in Blinbry zone, pulled retrievable center spear and 1-5/8" drill pipe.
5. Perforated 2-7/8" Drinkard casing w/10 oriented shots into Blinbry string @ 5925-5935.
6. Ran 2-1/16" tubing w/seating nipple set @ 5994'.
7. Ran rods and pump, returned to production.
8. On 24 hour test, 11-16-73, pumped 11 ENO, no water, gravity 35.2, GOR 7500.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices. In addition, such proposals and reports should include reasons for the abandonment; data on any former or present productive zones, or other zones with present significant fluid contents not sealed off by cement or otherwise; depths (top and bottom) and method of placement of cement plugs; mud or other material placed below, between and above plugs; amount, size, method of parting of any casing, liner or tubing pulled and the depth to top of any left in the hole; method of closing top of well; and date well site conditioned for final inspection looking to approval of the abandonment.
