4. Perforated Bliney and Tubb strings w. JSPF 6950-65, and 7070-75'.
5. Ran seating nipple, rods and pump, returned to production.
6. On 24 hour test 1-27-74, produced 2-2 BNC, 2 BSW, gravity 38.7, GOR 4300.
