We have been producing this well in the South McCormack Silurian Field. We propose to plug back to the Drinkard formation, perforate, set a cast iron bridge plug with 1 sack cement on top. Then we will acidize with 3000 gal. and fracture with 46,000 gal. gelled salt water and 40,000 lbs. 20/40 sand. Will run 2-3/8" tubing and set a packer prior to taking potential test.

* 35' cement required on top of C.I.B.P.
