The following must be completed by the operator for a satisfactory abandonment.

1. The surface location is to be cleaned and leveled as per U.S.G.S. requirements.
2. Private Surface: Abandonment stipulations to coincide with operator landowner agreement. (Where no agreement exists, the BLM will be contacted to provide abandonment stipulations.)
3. The drill pad and .1 miles of access road should be ripped to a minimum of 12" in depth.
4. The drill site (including reserve pit area) and .1 miles of access road should be reseeded according to the attached recommendations.
5. All ripped surfaces are to be protected from vehicular travel by constructing a dead-end ditch and earthen barricade at the entrance to these ripped areas. The barricade is to be constructed using spoil material from the ditch and should be of sufficient magnitude to discourage vehicle entry.
