1. Move in and rig up Leatherwood Drilling Company.
2. Sput 12 1/4" hole at 4:30 p.m. 11/24/72.
3. Drilled to 365' for surface casing.
4. Ran 10 jts. (351') 8 5/8" 24# J-55 used casing. Set at 365'.
5. Cemented using 250 sacks Class "C" cement with 2% CaCl. Circulated 75 sacks to pit. Plug down at 7:50 a.m. 11/25/72. SI - WOC.
6. After 12 hours pressure tested casing to 1000 psi for 30 minutes without loss of pressure.
7. Drilling ahead with a 7 7/8" bit.
