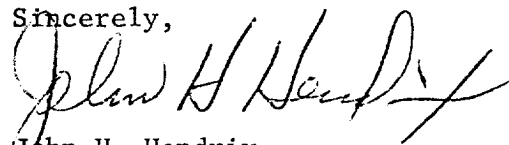

Enclosed herewith is my application for administrative approval of the dual completion of the John Hendrix Cossatot "G" Well No. 1 in the East Brunson Granite Wash and Drinkard Pools and John Hendrix Cossatot "H" Well No. 1 in the Wantz Granite Wash Pool. I request that approval be granted to produce the Drinkard Zone up the tubing-casing annulus should the gas-oil ratio be in excess of 100,000-1. If the GOR is less than 100,000-1, the completion would be a conventional dual using two strings of 2 1/16" tubing. Essentially, this would be similar to NMOCC Order No. R-4485 that pertained to dual completion of my Cossatot "B" Nos. 2 and 3 in the Drinkard and Wantz Granite Wash Zones.

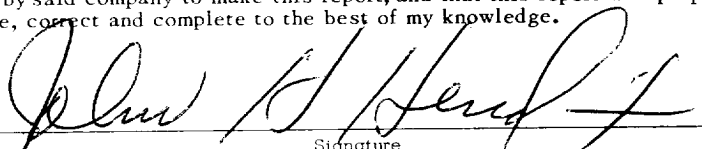

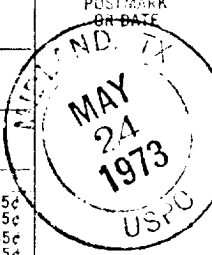
