
Gentlemen:

We respectfully request administrative approval of the unorthodox location of the Sims Well No. 7 for a completion in the Tubb Gas Pool. This well was originally drilled and completed in the Drinkard Pool with its location being orthodox for that completion. It locates in Unit C, 380 feet from north, 330 feet from east, and 2310 feet from west lines of the northwest quarter Section 24, T-22-S, R-37-E, Lea County, which location does not meet the minimum of 660 feet from the outer boundaries of the Tubb Gas proration unit. We enclose a proration dedication plat reflecting the well location as well as a separate plat reflecting offset operators and well completions.

Offset operators per the attached list have been notified by certified mail of this application. Further, it is understood that assignment of allowable to this well, which will share the proration unit with Well No. 3, is subject to the Commission's approval of its completion reports and our dual completion application. Those forms are being submitted through regular channels under separate cover.

Your consideration and approval, subject to the waiting period as provided under Rule 104, Paragraph F, will be appreciated.

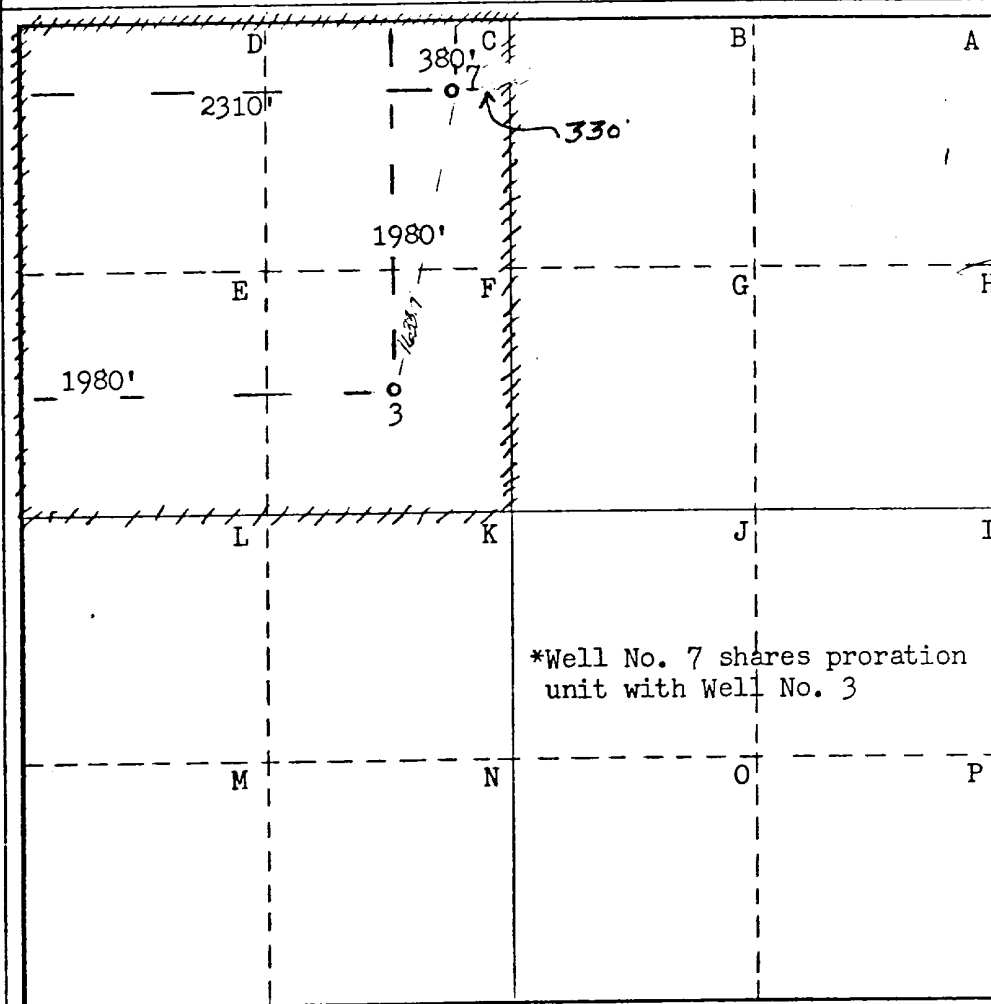
