1. MIRU casing pullers.
2. PU 1½" tbg & RIH to spot 100' cmt plug (2900-3000') (10 sx). Pull up and circ out excess cmt. WOC. Tag plug. Load hole w/mud laden fluids. POH w/tbg.
3. Weld on 4½" casing pull nipple.
4. Stretch casing and shoot off at approx 2000'.
5. POH & L.D. csg.
6. RIH w/tbg to spot cement plug 50' in and out of 4½" csg stub (35 sx) (approx 1950-2050').
7. Spot 100' cement plug 281-381' (35 sx) (8 5/8" casing shoe).
8. Spot 15 sx plug at surface w/required marker.
9. Clean location.
