Set at 3950'. Cemented with 365 sacks Howco Light with 5#'s salt per sack and 200 sacks 50/50 pos and 2% Gel and 5#'s salt per sack.  
Plug down @ 8:45 PM on 2-15-74.

3. After 24 hours pressure tested casing to 2500 psi for 30 minutes without loss of pressure.  
Released rig at 11PM on 2-16-74.
