Gentlemen:

The annual Gas-Oil-Ratio Test for the above-referenced well indicated this well should be reclassified from an oil well to a gas well in the Blaine Oil & Gas Pool, with the allowable being cancelled effective January 1, 1998.

If for some reason you feel this test does not reflect the proper classification of this well, please submit another test for our consideration by December 29, 1997.

If the well is to be reclassified from oil to gas you will need to submit the following:

- 1.) Form C-102 acreage dedication plat for the well, outlining a standard 640 acres proration unit or application for a NSP.
- 2.) Form C-104 showing reclassification from oil to gas effective January 1, 1998, indicating transporters of condensate and dry gas for this well.
- 3.) Indicate if gas well gas is separately metered.
