Change of intent from P&A to plugback & sidetrack well.

It is proposed to plugback as follows:

MIRU, kill well. NU BOP, POOH w/2 7/8" tbg. Set CIBP @ 12,500' w/35' cmt. RIH w/2 7/8" tbg to 12,140'. Circ hole, spot 30 sack plug 12,140'-11,940' POOH w/tbg. NU BOP, cut & pull 10,750' 5 1/2" csg, RIH w/tbg to 10,800', spot 35 sx cmt 10,800'-10,700' WOC & tbg, POOH w/tbg. Set 7 5/8" CIPB @ 9000'. Set 7 5/8" pkr @ 7900' or above split, sqz w/60 sxs pull & set pkr @ 3900' test csg 3900'-7900', POOH w/tbg. Set 10 3/4" pkr @ 3550', sqz w/100 sx. Test csg 3550'-surf. POOH, ND BOP & rig down pulling unit.

It is proposed to sidetrack as follows:

MIRU Patterson #80, cut window @ 9000', drl 6 1/2" hole & run 4 1/2" tbg to 13,900'. Log & run csg to surf. TOC 8000'.

Well name will change to Mary "A" Federal #1.
