On 8-16-82 moved in service unit. Pulled packer and tubing. Ran tubing to 11805' and spotted an 80 sack class H cement plug. Pulled tubing to 10000'. WOC. Tagged cement at 11026 and pulled tubing. Cut 9-5/8" casing at 4676' and pulled. Ran tubing to 5164' and spotted 75 sacks of class H cement. WOC. Ran tubing to 5164' and did not tag cement. Loaded casing with 36 BW and spotted 80 sacks class H cement. WOC. Tagged cement at 4920'. Ran tubing to 4731' and spotted 75 sacks of class H cement. WOC. Tagged cement at 4610'. Pulled tubing to 1905'. Set 150 sack class H cement plug. Pulled tubing to 784' and spotted a 75 sack class H cement plug. Spotted a 15 sack surface plug. Welded on cap and erected PXA marker.
