On 3/27/00, MIRU. Blew down tubing and casing to plant. Pumped 25 bbls 2% KCl down tubing; pumped 120 bbls 2% KCl with 55 gals R-2264 down casing. Acidized Atoka 12,386' - 12,410' with 2400 gals 20% MSR acid foamed to 50Q with CO2. Flowed well to test tank for 5 hours and recovered 24 BLW. Opened well to plant. Well producing @7 AMjwith 100# FTP to battery on 3/28/00. As of 4/3/00 producing 782 Mcf on gas lift with 222 bbls fluid.
