Citation acidized the Atoka perforations in the above mentioned well by bleeding off gas on casing and tubing to 0# via T. T. No rec. RU PT. Pumped 25 bbls 2% KCL wtr w/clay stab dn tubing. On vac. Pumped 120 bbls 2% KCL wtr w/clay stab mixed w/55 gals Champion R-2264 dn annulus. On vac. RD PT. Shut well in. RU Halliburton. Acidized Atoka from 12386'-12410' w/2400 gal 20% MCA acid carrying 300 gal methanol & foamed to 50 Q w/CO2. Flushed to top perf w/70.1 bbls of 2% KCL foamed to 50 Q w/CO2.

Citation vented +/- 400 MCFD from 2-14-97 to 2-16-97 after receiving verbal approval from Amando Loquez at the BLM in Hobbs NM.

The well was placed back on production 2-17-97.
