Rigged up pulling unit, pulled tubing. Went in hole with Halliburton RITS packer and set at 6450'. Squeezed perforations 6894-6902' with 125 sacks Halliburton Incon Class "C" cement. Squeezed at 1600 psi with top of cement at 6880'. Rigged down pulling unit after pulling RITS packer and tubing.

Shut down, waiting on drilling rig prep to resume drilling to Bone Springs formation. Drilling rig on Lisa Federal #1 will be used to deepen this well.
