It is proposed that the subject well be temporarily held in it's present condition to be converted to a water disposal well in the near future. Several remedial projects are planned on adjacent leases that, when completed, will undoubtedly require produced water disposal facilities in addition to those currently in operation. The current water production is gathered and piped to a common tank battery that is on the same location as the subject well, then pumped three miles to a water disposal well. It will be much more convenient and cost effective to convert the subject well to a water disposal well and use the existing facilities to inject the produced water into an approved disposal zone.
