- 03/12/85 Opned well up - 80# press. Fl @ 2600' f/surface. Swbd 19 BBLS fl. Well swbd dn. First run all oil, last runs were 5% cut of oil - 95% Ac wtr. Frac well w/50,000 gal gelled wtr, 90,000# 20/40 sd. Avg rate 20.6 BPM; avg press 3550#. Tot fl was 1264 BBLS. ISIP 1600#, 15 min 1100#. SIFN.  
DAILY COST: \$26,640.00 CUM COST: \$446,939.00 (DS)
- 03/13/85 No press on tbg when opened well up. Pulled tbg & pkr. RU CRC Wireline and perf f/5598-99', 5606-5700'; 20 holes. Ran BP, pkr, & tbg. BP set at 5750'; pkr set at 5549'. Spotted 100 gal Ac over perfs. Acidized well w/3,000 gals 15% NE Ac. Min rate 4.6 BPM - max & avg rate 4.6 BPM. Min press 1700#, max 3600#, avg press 2300#/ Well broke dn at 500# psi. Dropped 40 ball sealers. Did not ball out. ISIP 1000#, 15 min 400#. RU & swbd Ac wtr back. Did not have show of oil. Fl standing at 2000' f/surface when SD. Tot rec - 139 BBLS Ac & wtr.

- 03/14/85 Opened well up - 200# press. Fl @ 1200' f/surface. Swbd 206 BBLS oil & wtr. Last runs showed 50% oil & 50% wtr. Fl down to 2100' f/surface when quit swbg. RU Halliburton & frac well w/ 50,000 gal gel wtr, 90,000# 20/40 sd. Avg rate 25 BPM. Avg press 4655#, max press 5160#. ISIP 1390#, 15 min 1120#. Tot load wtr - 1238 BBLS to rec. SIFN  
DAILY COST: \$32,254.34 CUM COST: \$486,654.94 (DS)
- 03/15/85 Opened well up - no press - on vac. Ran tbg to retrieve BP. Had 40' sd on BP. Washed sd f/5710'-5750'. Retrieved BP & COH w/tbg, pkr, & BP. PU Hydrostatic Bailer and ran tbg in to clean sd to TD. (5955'-6063') 108 feet. COH laying dn 2 7/8" tbg. SIFN  
DAILY COST: \$5,626.60 CUM COST: \$492,281.54
- 03/16/85 Fin laying dn 2 7/8" J-55 tbg. RIH w/192 jts 2 3/8" tbg, set at 6020'. Pmp set at 5984', tbg anchor set at 5516'. Ran 74 jts 7/8" rods, 163 jts 3/4" rods, 2 x 1 1/2 x 16 pmp. Put well on pmp.
