Ran 295 jts. 9 5/8", 43# & 47# S-95 Buttress casing - Set @ 12,000' w/DV Tool @ 5081' Cemented 9 5/8" casing in 2 stages as follows:

Stage #1: Cemented w/2900 sx Lite, 3#/sx Gilsonite, 1/4#/sx flocele, .6% Halad 9 and 400 sx Class "H" w/.4% HR-7. Open DV tool and circulate 275 sx.

Stage #2: Cemented w/1060 sx Lite w/3#/sx Gilsonite, 1/4#/sx flocele, .6% Halad 9 and 200 sx Class C Neet - Circulated 110 sx to surface. Drill DV tool @ 5081' and test 9 5/8" casing to 2250 psi for 30 minutes - held OK.
