- The subject lease, #NM-63944, is in extended term (held by production). The expiration of the primary term was October 1, 1985.
- The Platinum 6 Fed #1 is the only well on the lease.
- The well is a stripper oil well.
- The lease is capable of production in paying quantities, but failure to suspend production will lead to premature abandonment due to current oil prices.
- It is presently uneconomical to pump the well, and we have shut down the pumping unit. However, the well is capable of natural intermittent flow, and we expect some small production from time to time. We are willing to close the flowline valve at your order if it is necessary for compliance with 43 CFR 3103.4-2, and therefore, to hold our lease pending an improved economic climate.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
