10/15/94 PU & RIH with 155 Jts (4780') 2 7/8" Plastic coated Tbg with 5 1/2" Nickel Plated SL injection Pkr. Circ. hole with Pkr fluid and set Pkr at 4780' in 15000# tension. Test backside to 540 PSI for 20 minutes. (See Chart) RU Injection pump equipment and begin injecting. Initial Pressure = 0 PSI.


