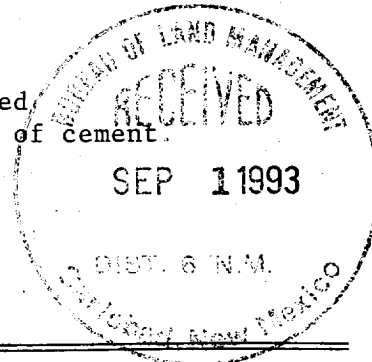

7-7/8" hole with 5-1/2" 15.5# casing set at TD (5400') with 690 sacks of cement
