Burlington Resources Oil and Gas Company intends to add Tresnor Sand pay as follows:


GIH w/ 4 3/4" bit and casing scraper on 2 7/8" tubing to PBTD @ 8854'. Pull tubing, scraper, and bit. Perf 8610'-8613', 8616'-8618', 8625'-8627', 8630'-8632', and 8649'-8657' (44 holes). Acidize down 2 7/8" tubing with 1500 gals 15% Ferchek SC. If frac is warranted, reset packer at 8500'. Frac down 2 7/8" tubing with 30,000 gals Delta Frac 200 and 100,000 lbs 20/40 Super DC sand. SION. Bleed off pressure. Clean out sand fill to PBTD @ 8854'. Reverse circulate hole clean. Set 2 7/8" tubing at ~8500'. Return to production.
