THIS WELL IS CURRENTLY COMPLETED AS AN OIL WELL IN THE TRISTE DRAW; DELAWARE, WEST POOL. THE FOLLOWING PROCEDURE IS TO RECOMPLETE THE WELL AS A SALT WATER DISPOSAL WELL IN THE BELL CANYON.

- 1) Set CIBP @ ~~8000'~~ ^{515'} w/ 35' cmt cap, above current perfs (8266'-8437').
 - 2) Perforate non-productive Bell Canyon, selectively, from 4600' - 5500' W/ 2 SPF.
 - 3) Acidize w/ ~ 10,000 gals 15% HCL.
 - 4) Run Injection packer on 2-7/8" IPC tubing. Set Pkr ~ 4550'.
 - 5) Test annulus to 500# on chart (chart to be sent to BLM). Commence salt water disposal operations.
