Cemented w/1330-sx Pacesetter lite 1/4#/sx celloseal + 2% CaCl + 5#/sx salt, tailed in w/200-sx "C" + 2% CaCl2. Plug held 1700 psi & circulated 170 sxs. Nipple up & tested to 2000 psi for 30 minutes. Reduced hole to 7-7/8" drilled out 8:30 PM 9/9/95.
