LEGAL DESCRIPTION:

AN EASEMENT FOR A PROPOSED FLOWLINE TO BE LOCATED IN SECTION 34, TOWNSHIP 23 SOUTH, RANGE 32 EAST, NMPM, LEA COUNTY, NEW MEXICO, SAID EASEMENT BEING FIFTY FEET WIDE AND BEING TWENTY FIVE FEET ON EITHER SIDE OF THE SURVEY CENTERLINE MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT FOR STATION 0+00.00 OF THIS SURVEY, FROM WHICH THE NORTH QUARTER CORNER OF SAID SECTION 34 BEARS N 39°04'30" W, 1052.91' FEET;

THENCE EAST, AT 150.0 FEET CROSSING THE CENTER OF A PROPOSED NEW ROAD FOR SURVEY STATION 1+50.0, A TOTAL DISTANCE OF 160.01 FEET TO A POINT FOR SURVEY STATION 1+60.01;

THENCE S 0°05'16" E, 2489.51 FEET TO A POINT FOR SURVEY STATION 26+49.52;

THENCE S 71°07'12" W, AT 12.1 FEET CROSSING THE CENTER OF A PROPOSED NEW ROAD FOR SURVEY STATION 26+61.6, A TOTAL DISTANCE OF 287.79 FEET TO A POINT FOR SURVEY STATION 29+37.31;

THENCE N 20°36'57" W, 158.66 FEET TO A POINT FOR SURVEY STATION 30+95.97;

THENCE S 89°34'27" W, 316.53 FEET TO A POINT FOR SURVEY STATION 34+12.50;

THENCE S 5°31'34" W, 18.32 FEET TO A POINT FOR SURVEY STATION 34+30.82;
