Procedure:

1. Set CIBP @ 7425' W/ 34 Cement on Top Tag
2. Spot cement plug from 4609' to 4709'
3. Pull 2500' of 5 1/2" casing
4. Spot cement plug from 2550' to 2450'
5. Spot cement plug from 595' to 695' - Tag
6. Spot cement plug from 25' to surface
7. Install dry hole marker, clean location.
