5/25/96: Finished running a total of 216 jts 5-1/2" 17# & 15.5# K-55 LT&C casing and set at 9348'. FC at 9300'. Pumped 125 bbls nitrified mud and soap w/ 20 bbls FW ahead of cement. Lead w/ 350 sx C-Lite (35:65:6) w/ 1/4 pps Cello-Seal. Tail w/ 700 sx C1 "H" containing 6 pps CSE, 2% KCl, and 0.2% FL-25. Displaced w/ 50 bbls 10% acetic acid + 2% KCl. PD at 5:45 a.m. CST. ND, set slips w/ 135,000#. Cut off 5-1/2" csg. NU tree. Set and clean pits. Released rig at 1:00 p.m. 5/25/96. WOCU.
