THIS WELL WAS TESTED IN THE DELAWARE "X" AND "Z" ZONES (8350-99') AND ACIDIZED - NOT FRAC'D FROM 4-8-97 TO 5-9-97. TEST INDICATED APPROXIMATELY 7-BWPD, SLIGHT SHOW OIL AND GAS TSTM.

ON 5-9-97 WELL WAS PUT BACK TO PUMPING FROM DELAWARE (8350-8499'), AVALON SAND-BONE SPRING (8679-91') AND BONE SPRING (8978-9137').

ON 5-9-97 MYCO CONTACTED THE OCD - HOBBS OFFICE AND REQUESTED VERBAL PERMISSION TO COMMINGLE THIS WELL FROM THE BONE SPRING AND DELAWARE STATING THAT THE DELAWARE WOULD NOT CONTRIBUTE TO THE HYDROCARBON PRODUCTION. THE OCD - HOBBS OFFICE ADVISED TO CEASE PRODUCTION FROM ONE OR THE TWO OTHER ZONES UNTIL A FORM C-107-A WAS FILED AND APPROVED.

THIS WELL WAS SHUT-IN ON 5-9-97 AND WILL REMAIN SO UNTIL THE C-107-A (APPLICATION FOR DOWN-HOLE COMMINGLING) IS FILED AND APPROVED.

MYCO IS OF THE OPINION THAT THE DOWN HOLE COMMINGLING IS MORE ECONOMICAL THAN SQUEEZING THE DELAWARE.
