Dear Mr. Westbrook:

Reference is made to the following: (i) your initial application dated December 29, 1998; (ii) the New Mexico Oil Conservation Division's ("Division") initial response to your application by letter from Mr. Michael E. Stogner dated January 5, 1999; (iii) your response by letter dated January 14, 1999; and (iv) the records of the Division in Santa Fe: all concerning John H. Hendrix Corporation's request for a 120-acre non-standard gas spacing and proration unit ("GPU") consisting of the following acreage in the Blinebry Oil and Gas Pool:

**LEA COUNTY, NEW MEXICO
TOWNSHIP 22 SOUTH, RANGE 37 EAST, NMPM
Section 11: N/2 SW/4 and SW/4 SW/4.**

It is my understanding that this unit is to be simultaneously dedicated to the following existing wells that are currently operated by John H. Hendrix Corporation and completed as Blinebry oil wells:

- (1) Thomas Long "A" Well No. 1 (API No. 30-025-25052), located at an unorthodox gas well location 1980 feet from the South line and 2310 feet from the West line (Unit K) of Section 11;
- (2) Thomas Long "A" Well No. 2 (API No. 30-025-25089), located at a standard gas well location 1980 feet from the South line and 990 feet from the West line (Unit L) of Section 11; and
- (3) Thomas Long "A" Well No. 3 (API No. 30-025-34035), located at an unorthodox gas well location 430 feet from the South line and 560 feet from the West line (Unit M) of Section 11.

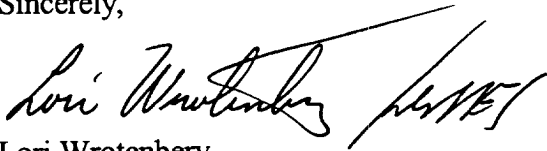
By authority granted me under the provisions of Rule 2(d) of the "Special Rules and Regulations for the Blinebry Oil and Gas Pool" as promulgated by Division Order No. R-8170, as amended, the above-described 120-acre non-standard gas spacing and proration unit and the resulting unorthodox Blinebry gas well location for both the Thomas Long "A" Wells No. 1 and 3

are hereby approved.

This newly established 120-acre GPU is to be simultaneously dedicated to the above-described Thomas Long "A" Wells No. 1, 2, and 3, with allowable assigned thereto in accordance with Rule 5 of the special Blinbry Oil and Gas Pool rules based upon the unit size of 120 acres.
