ATTACHMENT TO FORM C-103:  
SUNDRY NOTICE FOR PROPOSED ABO/DRINKARD RECOMPLETION

Note: Work to begin as soon as well service unit becomes available.

Day 1: Rig up wireline unit. Set CIBP 7050'. Cap with 2 sacks cement via dump bailer.

Day 2: Perforate Abo with 3-1/8" casing gun, 2 SPF, as follows: 6645', 6649', 6651', 6657', 6762', 6764', 6772', 6785', 6793', 6796'. Rig down wireline unit.

Day 3-4: Run 2-7/8" tubing and packer. Set packer @ 6560'. Swab well down. Acidize Abo perfs with 2000 gals 15% HCl acid. Swab back load. Swab test Abo.

Day 5: Pull tubing and packer. Rig up wireline unit and set RBP on wireline at 6600'. Perforate Drinkard with 3-1/8" casing gun, 2 SPF, as follows: 6314', 6346', 6364', 6368', 6391', 6396', 6398', 6405', 6420', 6422', 6436', 6438', 6441', 6469', 6478', 6489'. Run tubing and packer. Set packer at 6250'. Swab well down.

Day 6: Acidize Drinkard with 3000 gals 15% HCl acid. Swab well back to test.

Day 7: Frac Drinkard with procedure to be determined.

Day 8-10: Swab to recover frac load. Swab test Drinkard.

Day 11: Prepare for down-hole commingling:  
Pull RBP. Re-run tubing, including mud anchor, seating nipple and tubing anchor.  
Run pump and rods and put well on production.
