Cemented 1st stage w/ 325 sx Interfil and 200 sx Cl "C" + 2% CaCl2. Plug down at 10:15 p.m. Float held, ok. Drop bomb @ 10:30 p.m. Circ csg, circ 50 sx cmt off top of DV tool.

11/20/98: Cemented 2nd state w/ 1100 sx Interfil and 100 sx Cl "C" + 2% CaCl2. PD @ 6:30 a.m. Close DV tool, circ'd 125 sx to pit. WOC, set slips, cut csg off & install B-Section. Finish NU. Test blind rams, pipe rams & manifold to 3000#. Test hydril to 1500#, all ok. PU BHA and TIH. Tag cmt.

11/21/98: Tag cmt at 3420'. WOC total of 24 hrs. Dr1 cement. TIH to 5068' and tag cmt. Dr1 cmt and float collar to 5160'. Circ. Shut pipe rams and test casing to 1500#, held ok. Dr1g cmt and shoe. Resume drilling formation.
