7/10/99: Ran 53 jts 13-3/8" 61# J-55 casing and set shoe at 2220', FC @ 2173'. RU BJ and cement csg w/ 825 sx Class C 50-50-10 + 5% salt and 1/4# CF. Tail w/ 300 sx C1 "C" + 2% CaCl2 and 1/4# CF. Circ'd 280 sx to pit. Plug down at 7:30 p.m. WOC. RD BOPs. Cut csg off and weld on head. NU BOP.

7/11/99: Tighten and repair bolt in BOP doors. Test blind rams, casing, and manifold to 500 psi, ok. PU BHA.

7/12/99: TIH and tagged cmt @ 1990'. Drlg cmt, plug, and FC. Test pipe rams to 500 psi, ok. Resume drilling formation.
